RULES OF CULTURAL EDUCATION CENTRE

- 1) A club member should attend the club business on day to day basis. Frequent absents result in to degrading the membership status i.e. withdrawal of regular membership and implementation of charitable contribution status. (In such cases a member not been able to exercise his rights in the club as a regular member but need to serve the club for the designated time as allotted, only successful completion of the charitable contribution period will activate the regular membership status again).
- 2) All club activities must be limited to official working hours, unless prior permission has been granted to the club/ members by the competent authority.
- 3) Usages of alcohol / cigarette / any drugs are prohibited in CEC premises and clubs rooms, for such incidents will result in to suspension / expulsion or degradation of the membership / designation status temporarily / permanently.
- 4) Few of the training sessions are normally handled by non paid personnel (for example Western and Fusion Music Club) often these instructors are club members.
- 5) Club member in no circumstances will deny his / her services whenever required by the CEC administration and its regulated clubs.
- 6) The service /skills of a club member may be rendered by other clubs activities / programmes.
- 7) Members are expected to volunteer themselves in community services initiated by the clubs.
- 8) A member in no way should obstructs the democratic culture related to clubs regulatory / electoral processes exercised by the CEC through his / her verbal / attitudinal or any other means. Guilty in such cases will result in to suspension / expulsion or degradation of the membership / designation status temporarily / permanently.
- 9) Equipment / Instruments of the clubs will be used in the provide club premises and will not be allowed to take outside unless prior written permission has been granted to do so.
- 10) In no circumstances any member of the CEC clubs will claim or accept monetary gains from any of the University units, it will be considered as the punishable offence.
- 11) The members of the club will not permitted to invite other artists or students who are not the CEC member for the current session for any practice session or events unit the permission will be granted to do so. Failing to this result into strict disciplinary actions and considered as breach of code of conduct.
- 12) Club participants may be required to travel to events during vacations time.
- 13) I understand and agree that this platform has been extended to me to explore creativity, develop, learn and practice interpersonal and leadership skills that has significant impact on my professional and personality development and associated groups and university fraternity at large.
- 14) I understand and agree that there is a risk of some injury to me while utilized university CEC facilities, equipments and programmes and recognize every activity has a certain degree of risk, some more than others.
